- 1. Waiver and Release. Volunteer does hereby release and forever discharge and hold harmless DMAR and its successor and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's participation. Volunteer understands that this Release discharges DMAR from any liability or claim that the Volunteer may have against DMAR with respect to any bodily injury, personal injury, illness, death or property damages that may result from Volunteer's participation, whether caused by the negligence of DMAR or its officers, directors, employees, volunteers or agents or otherwise. Volunteer also understands that DMAR does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance except as DMAR has disclosed in writing. Volunteer specifically understands that DMAR shall not be responsible for supervising, managing or controlling those persons set forth above.
- 2. <u>Medical Treatment.</u> Volunteer does hereby release and forever discharge DMAR from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment or service rendered in connection with the Volunteer's participation.
- 3. <u>Assumption of the Risk.</u> There are hazards on every work site. Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities and releases DMAR from all liability for injury, illness, death or property damage resulting from the activities of the Volunteer's participation.
- 4. <u>Insurance.</u> DMAR does not carry or maintain, and expressly disclaims responsibility for providing any health, medical or disability insurance coverage for the Volunteer. Volunteers are not to be deemed employees or agents of DMAR, and DMAR shall not be responsible for the purchase of worker's compensation insurance.
