- ✓ (Residential) 3,122 represents the lowest June on record. The previous low was in 2015 with 6,197 active listings.
- ✓ (Detached) 2,137 represents the lowest June on record. The previous low was in 2020 with 4,082 active listings.
- ✓ (Attached) 985 represents the lowest June on record. The previous low was in 2015 with 1,166 active listings.

CLOSE PRICE — MEDIAN

- ✓ (Residential) \$545,000 represents the highest amount on record. The previous record was May 2021 of \$537,000.
- ✓ (Detached) \$600,000 represents the highest amount on record. The previous record was May 2021 of \$592,200.
- ✓ (Attached) \$380,000 represents a tie for the highest amount on record. The previous record was May 2021 of \$380,000.

CLOSE PRICE — AVERAGE

- ✓ (Residential) \$643,645 represents the highest amount on record. The previous record was May 2021 of \$621,407.
- ✓ (Detached) \$728,385 represents the highest amount on record. The previous record was May 2021 of \$699,410.
- ✓ (Attached) \$440,066 represents the highest June on record. The previous record was 2020 of \$369,918.

- ✓ (Attached) 0.54 months represents the lowest June on record. The previous record low was 2015 of 0.66 months.
