- ✓ (Residential) 1,477 represents the lowest amount on record. The previous low was in March 2021 with 1,921 active listings.
- ✓ (Detached) 968 represents the lowest amount on record. The previous low was in February 2021 with 1,120 active listings.
- ✓ (Attached) 509 represents the lowest amount on record. The previous low was in May 2021 with 739 active listings.

CLOSE PRICE - MEDIAN

- ✓ (Residential) \$545,000 represents a tie for the highest number on record. The previous record was June 2021 of \$545,000.
- ✓ (Detached) \$599,990 represents the highest December on record. The previous record was 2020 of \$502,775.
- ✓ (Attached) \$381,500 represents the highest December on record. The previous record was 2020 at \$330,000.

CLOSE PRICE – AVERAGE

✓ (Residential) \$626,573 represents the highest December on record. The previous record was 2020 of \$540,998.

- ✓ (Detached) \$705,753 represents the highest December on record. The previous record was 2020 of \$610,464.
- ✓ (Attached) \$441,390 represents the highest December on record. The previous record was 2020 of \$388,122.
